INDICTMENT

In Violation of:
Title 21, U.S.C. § 846
Title 21, U.S.C. § 841
Title 18, U.S.C. §924(c)

COUNT ONE

The Grand Jury charges:

1. That on a date unknown, but no later than 2006 through December 19, 2008, in the Western Judicial District of Virginia and elsewhere, the defendants, ALVIN LEWIS MACAULEY, aka "Al" or "Chief"; MEGHAN RAE JONES; RALPH HOUSON COVINGTON, JR.; and DORRAINE KAY COVINGTON, aka "Dodi", knowingly and intentionally attempted and or combined, conspired, confederated and agreed with diverse other persons known and unknown to the Grand Jury, charged and uncharged, named herein and in other indictments or elsewhere, to commit the following offenses against the United States, to wit: to possess with intent to distribute and to distribute more than 100 grams of a mixture or substance containing a detectable amount of heroin, a Schedule I controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(B).

2. All in violation of Title 21, United States Code, Section 846 and 841(b)(1)(B).

COUNT TWO

The Grand Jury charges:

1. That on or about the 14th day of January, 2008, in the Western Judicial District of Virginia, the defendant, MEGHAN RAE JONES, did knowingly and intentionally distribute a mixture or substance containing a detectable amount of heroin, a Schedule I narcotic controlled substance.

2. All in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT THREE

The Grand Jury charges:

1. On or about the 22nd day of March, 2008, in the Western Judicial District of Virginia, the defendant, ALVIN LEWIS MACAULEY, a/k/a "Al" or "Chief", did knowingly use and carry a firearm during and in relation to, and did possess a firearm in furtherance of, a drug trafficking crime which may be prosecuted in a court of the United States as heretofore set forth in Count One of this Indictment.

2. All in violation of Title 18, United States Code, Sections 924(c)(1)(A).

COUNT FOUR

The Grand Jury charges:

1. That on or about the 22nd day of July, 2008, in the Western Judicial District of Virginia, the defendant, MEGHAN RAE JONES, did knowingly and intentionally distribute, and possess with intent to distribute, a mixture or substance containing a detectable amount of heroin, a Schedule I narcotic controlled substance.

2. All in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT FIVE

The Grand Jury charges:

1. That on or about the 14th day of October, 2008, in the Western Judicial District of Virginia, the defendant, RALPH HOUSON COVINGTON, JR., did knowingly and intentionally distribute a mixture or substance containing a detectable amount of heroin, a Schedule I narcotic controlled substance.

2. All in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT SIX

The Grand Jury charges:

1. That on or about the 20th day of October, 2008, in the Western Judicial District of Virginia, the defendant, RALPH HOUSON COVINGTON, JR., did knowingly and intentionally distribute a mixture or substance containing a detectable amount of heroin, a Schedule I narcotic controlled substance.

2. All in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT SEVEN

The Grand Jury charges:

1. That on or about the 18th day of November, 2008, in the Western Judicial District of Virginia, the defendant, RALPH HOUSON COVINGTON, JR., did knowingly and intentionally distribute a mixture or substance containing a detectable amount of heroin, a Schedule I narcotic controlled substance.

2. All in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT EIGHT

The Grand Jury charges:

1. That on or about the 19th day of November, 2008, in the Western Judicial District of Virginia, the defendant, RALPH HOUSON COVINGTON, JR., did knowingly and intentionally distribute a mixture or substance containing a detectable amount of heroin, a Schedule I narcotic controlled substance.

2. All in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT NINE

The Grand Jury charges:

1. That on or about the 7th and 8th day of December, 2008, in the Western Judicial District of Virginia, the defendants, ALVIN LEWIS MACAULEY, aka "Al" or "Chief"; RALPH HOUSON COVINGTON, JR.; and DORRAINE KAY COVINGTON, aka "Dodi", did knowingly and intentionally distribute and did possess with intent to distribute, a mixture or substance containing a detectable amount of heroin, a Schedule I narcotic controlled substance.

2. All in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT TEN

The Grand Jury charges:

1. That on or about the 10th day of December, 2008, in the Western Judicial District of Virginia, the defendant, ALVIN LEWIS MACAULEY, aka "Al" or "Chief", did knowingly and intentionally distribute a mixture or substance containing a detectable amount of heroin, a Schedule I narcotic controlled substance.

2. All in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

COUNT ELEVEN

The Grand Jury charges:

1. That on or about the 12th day of December, 2008, in the Western Judicial District of Virginia, the defendant, ALVIN LEWIS MACAULEY, aka "Al" or "Chief", did knowingly and intentionally distribute a mixture or substance containing a detectable amount of heroin, a Schedule I narcotic controlled substance.

2. All in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).


COUNT TWELVE

The Grand Jury charges:


