I was sentenced to 6 (six) months jail for a probation violation ~ I'd never been in

trouble or jail until then. My prior was

Detective Investigator Arnold took my

Polygraph on July 11 or 13 2006 he told

Ms. Beauvais that my story is believable.

I was Sexually Harrassed and

Molested while Incarcerated at the

Pittsylvania County Jail by then a Corporal

Hank Hazelwood ~ Also again in April

2006 I was arrested + placed in

their custody and then/now Sargent Hank

Hazelwood molested me again - only →

this time I turned him in.

On my first Incarceration in 2004 I was also Assaulted by a Corporal Pickeral (Michael Pickeral) I filed charges as I was taken to Dr. Thompson's on Hwy 29 across from V-DOT & Virginia State Police Depot.

The officers that escorted me to that Magistrate was Sgt. Meyers + Corporal Blair. (Blair is now a Magistrate)

It took over 21 days to file charges as I had to file a grievance and go through the chain of commands. The Magistrate had even asked, "what took so long to file charges?"

I have two (2) witnesses that saw-heard Mr. Hazelwood Molest me

- 1) is Pamela Dowell whom is currently in Danville City Jail Annex. She wrote her testimony and mailed it to my lawyer Mr. Jesse Meadows III Chatham, VA.

- 2) Margaret Short: Has just been found I never could recall her name, we called her Bunny Rabbit. She is in Fluvanna Prison.

Now I also gave Ms. Beauvais the names of Penny Haskins, Eva Grover, Mary Hooker. I NEVER said "These girls were my witnesses to Mr. Hazelwood Molesting me", I stated to her

Ms. Beauvais that I heard that these woman had exposed their Breast or Vaginas to Mr. Hazelwood. I did say I saw Mary Hooker expose herself But, yet ALL THESE WOMEN! SUPPOSEDLY Denied to Ms. Beauvais it happen.

It has now been over 5 months since reporting this: NOTHING HAS HAPPENED! Ms. Beauvais has NEVER

My Name is Pamela Dowall

I was incarcerated on 9th of July 2004  
in the Pittsylvania County Jail, Chatham VA,

I'm writing a complaint and asking for assistance  
in filing charges against P.C.J. for Harassment  
and assault. First off Mrs. Eva Perkins  
whom is the Jail Nurse was Ver bably Abusive  
along with physically. She was also Neglegent  
of her duties.

I have been being treated by a Nuerologist  
Dr. Doonquah. Mrs. Perkins told me my medications  
could be altered to her discretions I was also  
instruted. to urinate for them ~~that~~ I couldn't go  
at that time so Sgt. Lee & Mrs. Perkins waited thr.  
as I drank water and stated "If I dont go I'll be  
charged for disobeying a direct order" I finally went  
I layed there on a mat on a concrete Floor with  
what I have is degenerative disc disease, herniated disk  
High Blood Pressure; peripheral nerve damage left upper  
extermity's left leg. I was shot. I suffer a lot of  
discomfort. The pain there was unbearable. I suffered  
discomfort and pain I had filed kites  
the protocol in seeing a doctor or going through the  
Chain of commands Nothing was done for me  
finally after 2 wks I was help<sup>ed</sup> with some medication  
and felt a little relief my pain is really unbearable

on BACK → →

without medications. I am facing back surgery in 2006.

The mental → emotional <sup>physical</sup> abuse occurred when <sup>physical</sup> Ms Perkins

threw a Koolaid pitcher at me, why cause she was in a bad mood. I was also subjected to harassment by a Corporal Hazelwood asking to show my breast.

personal area, below, in area. below in exchange for cigarettes, food, drinks, phone priviledges. It was awful

I remember pretending to be asleep & Hazelwood came to trap door called Sheril, Carr and told her to

undies put your ass against the trap. Ms Carr was crying. Mr Hazel molested her. I told her not to let

him scare her into doing that I was scared. It was awful. He though myself and another girl we

called Bunny Rabbitt. Real name Margie Maragret. She thought we were asleep. its really awful to live in fear while in jail.

I've only told in a letter I wrote to Mr. Meadows Lawyer I gave a statement. and to Sheril. She knew

that night he molested her. I was pretending to be asleep. There were other girls that exposed themselves.

Mr Hazelwood Always was perverted spying on us as we use the toilet opening our door as we

underssed opening our door as He is a sick pervert.

I wanted women come & go in HZ & watched Hazelwoods Ms conduct as women came & went.

I also was present when a Michael Pckeral, a corporal, got mad at Ms Carr. because she had been hollering
