

Recalling being

jailed, On March 11, 2004, I, Sherril A. Carr-McGuire was sentenced to 6 months of jail. I had to do my time in Chatham Holding Cell #2. During my time there, different girls were in and out of there. I believe in "May" it began. Hank Hazelwood telling me to show my breasts, threatening me a Contaminant Charge. as he would give me (us) cigarettes he gave Marlboro 100's I believe that what he'd give me either he'd put them into a toilet paper roll and hand it through the trap, or in the shower I'd lift up the trash bag inside the garbage can would he leave for a cigarette and a pack of matches he'd get the matches from the janitor's room office. Inside the top drawer is a Box of mints. Or then I was threatened with a indecent exposure Street Charge. Mr Hazelwood at one time sent Debbie from the Control room out so she could smoke. Mr. Hazelwood called me to the trap it was passed 11 pm because lights were out & it was lockdown. A girl named Pam (Blonde hair) and a girl whom we called Bunn's Rabbit was there <sup>they</sup> pretended to be asleep, because they knew how Hazelwood was towards me. Everyone would ask (Pam) she was close to me. I went to the trap he told me to bend over he placed his fingers inside of my vagina for about 2/3 mins. he was on his knees. There is a camera I believe so if you look at any tapes from the dates I was incarcerated you'd see him doing this. it should also show how many times Hazelwood would come to my door. Numerous times just opening our door. We'd be naked, dressing, on the toilet

my boyfriend stating he wanted to date me  
 oh dont tell mr. Hazelwood said I  
 am married live in danville I'd lose my wife  
 and my job with the threats I'd not tell  
 but people had seen, people have heard  
 the 3 girls I named already you'll  
 have to look at the records & tell me  
 Bunny rabbit name & Pam Shell have her  
 last name on record Also took back to  
 March 2004 - Aug 2004 Mr. Hazelwood wrote me a  
 letter. I never threw it away if I can find all my  
stuff. I was a drug addict on Crack cocaine! I saved  
 all my letters & jail stuff in my black backpack.  
 Somewhere that letter is. I have had alot of things  
 stolen to while Im in jail people go through your  
 things with crack heads. Hazelwood wrote  
 quote "Do I like my pussy fucked hard?"  
 Do I like anal sex? where do I live?  
 Mr. Hazelwood come by after I was release.  
 But never saw me so he'd leave He told  
 me this April 2006. I had seen what

I do not remember the vehicle it was  
night time in Aug/Sept 2004. I talked to  
another inmate when she said she knew the  
officer I could trust, so I confided in them

Then on 6-12-06 I had court I was scared  
I'd have to see Hazelwood again I was  
The officer who picked me up and I know  
I told her everything she was going to see  
an investigator named Veronica of Pittsylvania County  
As she said she trusted her.

I'm now telling my story now due to I was  
scared I did not want to be molested or  
gripped again by Hazelwood. I was also  
scared upon release date Aug 2004 due to  
street change threats.

Also during this time Corporal Pickett  
injured me he slammed the trap shut on  
my fingers he told me to shut the back  
up as I had not showered in 3 days  
and it was approx 2 or 3 am I wanted  
a shower he said if I said one more  
thing he'd slam the trap. I said  
bwaah. He kicked it shut when it  
slammed my fingers in it, I lost 3 long  
nails I filed a grievance where I was

After my complaint Hattie decided  
going through the chain of command  
Not satisfied, I believe it was Sheriff

Plaster's decision to go to the Magistrate  
I was escorted by Sgt Meyer and Corporal  
Blair The young dark haired man the Magistrate  
took my complaint. I was taken to  
the doctors office on Hwy 29 It will be  
on record. I had Nerve damage and  
something else will also be in medical  
records. I never went to Court  
but want to proceed in that too

As I still require surgery my left ear  
is damaged due to this, I had to  
wear bandages band-aids for 2/3 weeks  
changing them every few hours. There are  
X-rays and I believe pictures. It's the  
Dr. office kind of access from Hwy patrol  
V-Dot on Hwy 29 Is it Dr. Thompson?

If I can remember anything else  
I'll tell you also there is 3 more  
quib that Mr. Hazelwood has done
